His experience also extends to large-scale and regional strategic planning such as the SCAG Compass Blueprint effort and the San Bernardino Countywide Vacant and Underutilized Land studies.

In all of his projects, Colin uses his understanding of policy and land use planning to balance fiscal sustainability, preserve community lifestyle, and achieve community vision.
